11 **ORDER**


12 **IT IS ORDERED** that the appeal is dismissed.

15 **NOTICE**

16 The parties are advised that, pursuant to A.R.S. § 41-1092.09, this Order shall be final  
17 unless Petitioner submits a written motion for rehearing no later than thirty (30) days after service  
18 of this decision. The motion for rehearing or review must specify the particular grounds upon  
19 which it is based as set forth in A.A.C. R20-4-1219. A copy shall be served upon all other parties  
20 to the hearing, including the Attorney General, if the Attorney General is not the party filing the  
21 claim of error. In the alternative, the parties may seek judicial review of this decision pursuant to  
22 A.R.S. § 41-1092.08(H).
