**NOTICE OF LICENSE EXPIRATION**

7 The Superintendent of Financial Institutions for the State of Arizona, (the "Superintendent"),  
8 finds, pursuant to Arizona Revised Statutes ("A.R.S.") Section 6-904(B), that mortgage broker license  
9 #0907909 for V-Line Mortgage, LLC, is expired. Specifically, A.R.S. § 6-904(B) states, "A licensee  
10 shall pay the renewal fee on or before September 30. Licenses not renewed by September 30 are  
11 suspended and the licensee shall not act as a mortgage broker until the license is renewed or a new  
12 license is issued pursuant to this article. A person may renew a suspended license by paying the  
13 renewal fee plus twenty-five dollars for each day after September 30 that a license renewal fee is not  
14 received by the Superintendent and making application for renewal as prescribed by the  
15 Superintendent. Licenses which are not renewed by October 31 expire. A license shall not be granted  
16 to the holder of an expired license except as provided in this article for the issuance of an original  
17 license." V-Line Mortgage, LLC did not renew its license by October 31.

18 Pursuant to A.R.S. § 6-903(A), "A person shall not act as a mortgage broker if he is not  
19 licensed under this article." V-Line Mortgage, LLC may not transact business in Arizona as a  
20 mortgage broker until such time that V-Line Mortgage, LLC is licensed. Transacting business as a  
21 mortgage broker without a license is a violation of statutes and subject to administrative action by the  
22 Superintendent. Pursuant to A.R.S. § 6-132, the Superintendent may assess a civil money penalty of  
23 up to five thousand dollars (\$5,000.00) per day per violation.


